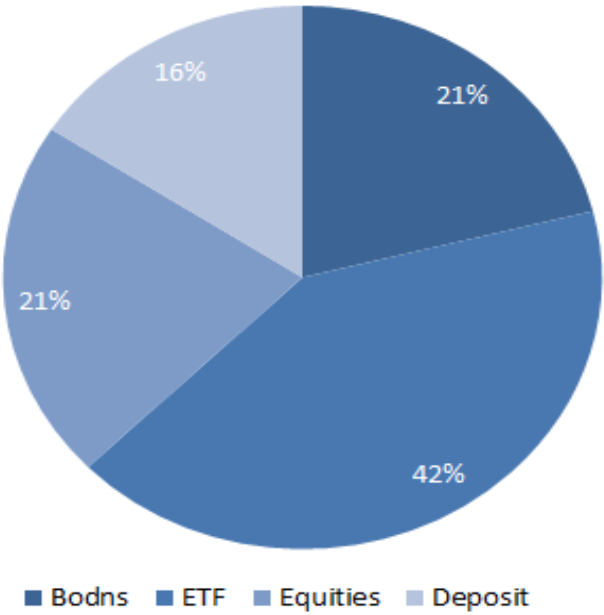
Recommended investment horizon



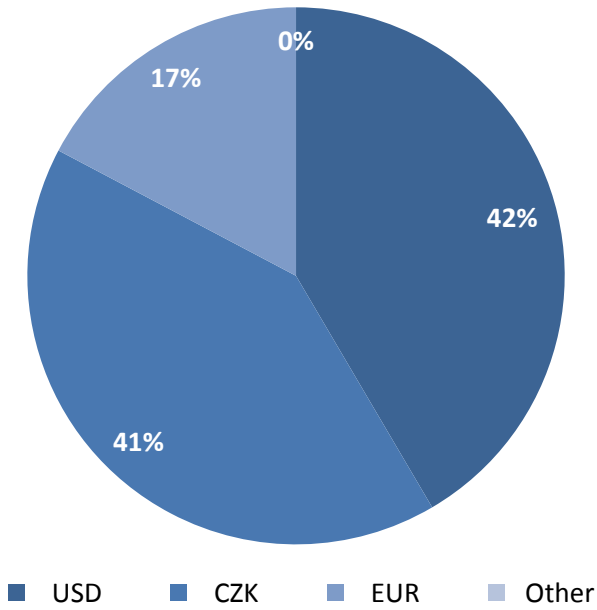

Investment policy

Raiffeisen fond dividendový invests mainly in global equity instruments and, to a lesser extent, also in global bond instruments. The Fund’s investment strategy aims at generating profit not only by increasing the value of its securities but also by way of dividends paid out. The Fund assets have been invested mainly in equities of companies that pay dividends, that is, predominantly major and stable enterprises that share a portion of their generated profits with their shareholders. As far as the Fund’s regional outreach is concerned, the equity portion of the Fund has had a global target; currently, a major part of the Fund assets will be invested in the United States and Europe, and furthermore in the emerging markets and in the Pacific area. Profit generated by the Fund Class A1 will be reinvested in the Fund assets.
