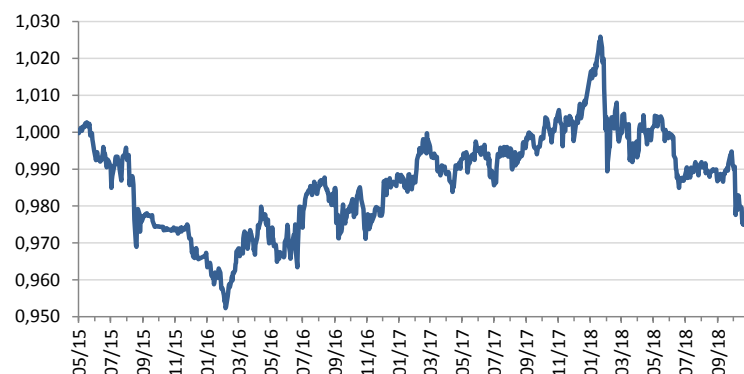

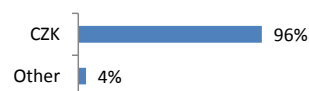

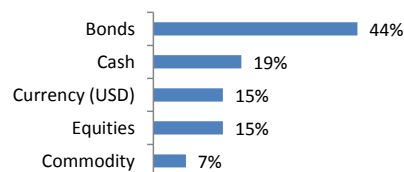
## Recommended investment horizon
