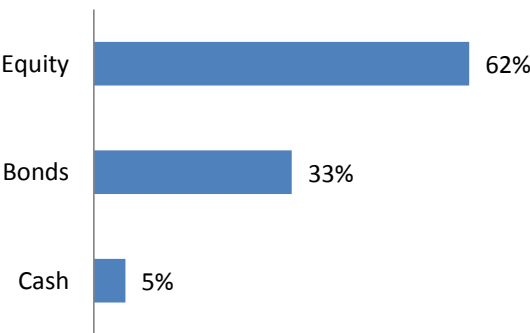

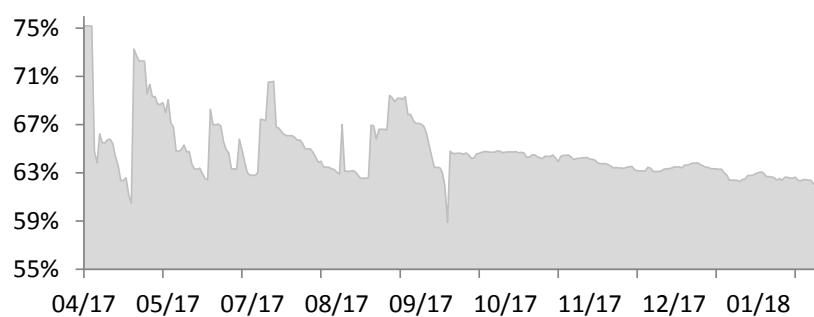

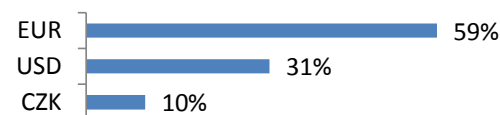


INVESTMENT IN EQUITY AND ETF



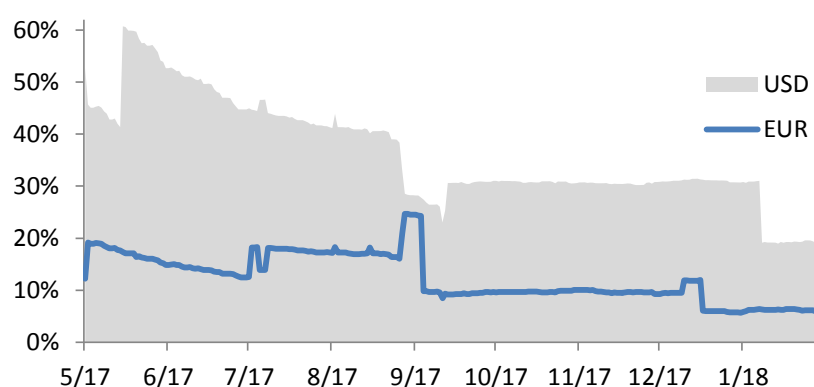
Share of investment in equity and ETF 62,00 %

OPEN POSITION OF FOREIGN CURRENCY OVER TIME

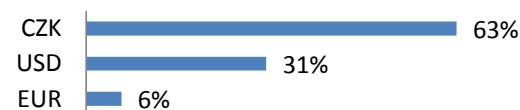

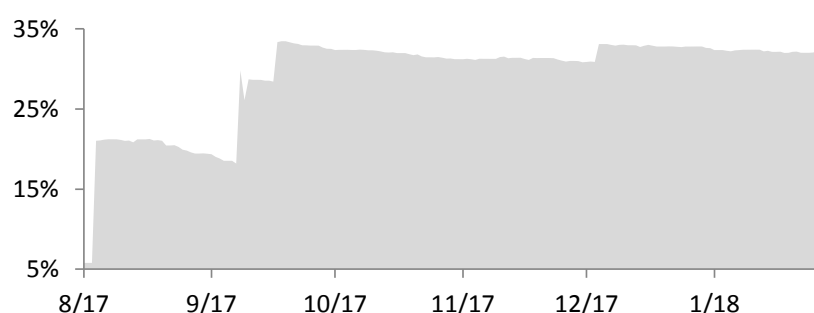

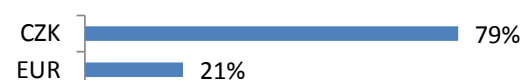


BOND INVESTMENT

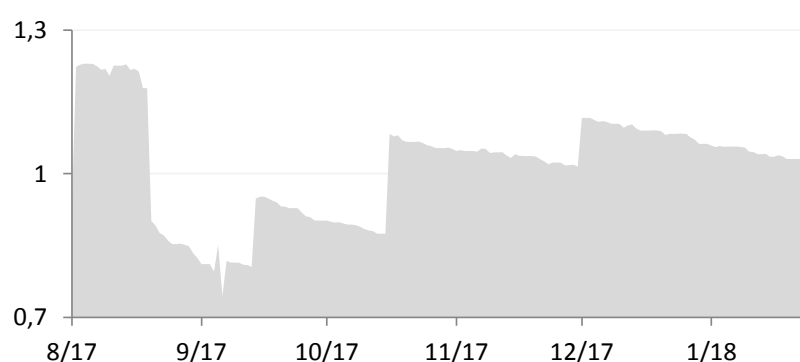


Share of bond investment 32,25 %

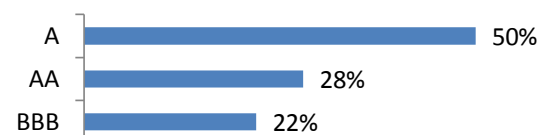
Currency allocation of bonds
